Regarding various demands of Himachal Pradesh D.El.Ed College
Welfare Association

Sir,

I am directed to refer to the subject cited above and to say that various demands of Himachal Pradesh D.El.Ed. College Welfare Association were under consideration at Government level for past some time. After due consideration, following decisions are conveyed regarding D.El.Ed. courses being run in Private institutions of Himachal Pradesh:-

1) Regarding conversion of Reserved categories seat to Unreserved Category:

After due consideration, it has been decided that there should be no conversion of category upto 2nd round of counseling. However, in the third round of counseling, if the sub-category seats are still unfilled, they shall be converted to main category (e.g.. SC-BPL shall be converted to SC). Further, if after 3rd round of counseling, seats still remain unfilled in particular category, then the same should be converted to Unreserved Category in 4th round.

2) Regarding increase in fee structure of D.El.Ed. Course:-

After due deliberations, it has been decided to revise and increase the tuition fees by 20% (for both subsidized & non-subsidized categories) and other miscellaneous fees by 10% for both the categories. The details of the revised fees are enclosed as Annexure-'A'.

3) Regarding increasing the management quota upto 40%:-


It has been decided that the management quota seats be increased from present 10% to 15% of the allowed intake capacity. Rest of the seats will be filled up as per existing structure of 50-50 percent between subsidized and non-subsidized seats.

4) Regarding no bar of Entrance Test for Management Quota Seats:-

It has been decided that for Management quota seats, the candidates having minimum educational qualifications prescribed by the NCTE will be considered subject to their appearing in Entrance Examination (for D.El.Ed.) conducted by HP Board of School Education. However, they shall be considered irrespective of their marks in the said Entrance Examination.

These decisions will be applicable from immediate effect. You are therefore requested to take immediate further necessary action accordingly under intimation to this Department.
